ROLLER SKATING RULES – Students please read and sign- parents initial

- I understand that the same rules during the school day, also apply at roller skating. I agree to follow these rules and skate safely.
- Instructions of skate guards must be followed. Skating in an unsafe manner or at an unsafe speed will not be tolerated
- No roller blades, Heelys or outside skates allowed.
- No food or drink in the gym.
- No middle or high school students allowed to skate unless they or their parent are a volunteer that evening.
- If there is severe weather or school has been cancelled/dismissed there will not be skating that evening. If you are on suspension from school you are not allowed to attend skating.
- 4th-5th grade skaters must be picked up at 8:30 pm. For safety purposes, please do not walk home alone! If you leave roller skating at any time, you will not be allowed back in.
- For safety reasons, no child will be allowed to enter before the specific start time.
- **Please have a number with you where we can reach your parent in the event of an emergency.** If you are asked to leave roller skating, your parent will be called for pickup and you will not be allowed to participate at the next skate event.
- In the event of an evacuation, you will leave the gym in an orderly fashion by way of the rear door and go out past the nurse's office. You will remain on the flat with the other students and PTO volunteers until your parent/guardian comes to pick you up.
